The unaudited condensed interim financial statements for the second quarter ended 30 June 2009 have been prepared in accordance with Financial Reporting Standards ("FRS") 134 - Interim Financial Reporting and paragraph 9.22 of the Listing Requirements of the Bursa Malaysia Securities Berhad ("Bursa Securities"), should be read in conjunction with the audited financial statements of the Group for the financial year ended 31 December 2008.

Explanatory Notes Pursuant to Appendix 9B of the Listing Requirements of the Bursa Securities

B1. Review of Performance

The Group has recorded a profit before tax of RM2.115 million on the back of turnover of RM28.590 million for the second quarter ended 30 June 2009 as compared to preceding year corresponding quarter profit before tax of RM1.098 million and revenue of RM27.278 million respectively. The Group achieved a revenue of RM58.091 million (2008: RM47,149 million) and profit before tax of RM4.204 million (2008: RM0.817 million) for the 6 months period ended 30 June 2009. Overall, the increase in revenue and profit before tax for the current quarter as compared to the 2nd quarter of 2008 were mainly due to increase in sales volume of the Group's products.

B2. Variation of Results against Preceding Quarter

The Group's profit before tax for the current quarter ended 30 June 2009 was RM2.115 million as compared to RM2.089 million in the preceding quarter ended 31 March 2009. The slight increase in profit before tax was due to full settlement of some of the borrowings in the current quarter, which reduced the finance cost.

B3. **Prospects of the Group**

The Board expects 3rd Quarter of 2009 remain a challenging quarter due to the continuing global economic crisis. However, the Board expects the performance of the Group for year 2009 to be profitable.
